Filing for Unemployment Compensation Benefits

Colleagues who leave Trinity Health or are placed on furlough may apply for unemployment compensation benefits.

Each state applies its criteria to determine an applicant's eligibility for unemployment compensation benefits.

You may apply for unemployment compensation benefits by visiting your local department of labor or unemployment agency web site for the state where you live. Most state agencies offer online or telephonic application. **Note: if you live in one state and work in another, you should still apply for unemployment compensation benefits in the state where you live.**
