You can request reimbursement for many common weight management services not covered by your health plan.

Below are examples of covered services.

Outpatient counseling or therapy that are not covered by the medical plan	<ul> <li>Claims processed through a health plan, including charges that have been applied to your Deductible and Out-of-Pocket Maximums</li> </ul>
Office visits rendered by a licensed Physician that are not covered by the medical plan	<ul> <li>Expenses submitted and reimbursed by any other health benefit plan.</li> </ul>

	<ul> <li>Services and/or programs not approved and/or provided in the United States</li> </ul>

#### How to submit a claim

- There are three ways to submit a receipt for reimbursement:
- Through the WageWorks EZ Receipts® mobile app.
   Use your mobile device to snap a photo of your receipts and submit them for reimbursement.
- Though your WageWorks account. Log in to your account at www.wageworks.com, select the Pay Me Back option, upload a digital image of your receipt, and submit your claim.
- Obtain a Pay Me Back claim form in the Help section on your WageWorks account. Fax or mail along with copies of receipts to address or fax number on the form.
